District Schedule: **First-round matches- 12 noon.** Finals and consolation finals start at conclusion of first-round matches.

First and second place wrestlers in each weight class at the Sectional tournaments qualify for the District tournament. First and second place wrestlers in each weight class at the District tournaments qualify for the State Wrestling Tournament.

COACHES: **Be sure to include the grade for each wrestler and be prepared to give the sectional tournament manager the record for each of your wrestlers.** Please be sure this information is accurate.

TOURNAMENT MANAGERS: **We would appreciate it if you would put the grade and record for each wrestler on the pairing sheets. Then on the sectional report form place the UPDATED record along with the grade. That will help the district manager when they complete their report form for state tournament program.
