**TO: ATHLETIC DIRECTORS AND TENNIS COACHES OF CLASS 2A SCHOOLS PARTICIPATING IN STATE TEAM TENNIS**

**RE: SCHEDULE AND INFORMATION**

Dear Athletic Director and Tennis Coach:

Congratulations on qualifying for the semifinals of the IHSAA State Team Tennis Tournament on May 28, 2019. The State Team Tennis Tournament for Class 2A will be held at Ankeny Tennis Courts at Prairie Ridge Sports Complex, 1010 NW Prairie Ridge Drive, Ankeny. Indoor facilities have been arranged, if necessary. Complete information about state team tennis, including links to maps, is on the IHSAA website at the following link –

**Information regarding seeding the tournament will be sent to you once all team questionnaires have been received in our office. Deadline is 10:00am, Monday, May 20. After seeding has been completed the bracket will be available online.**

**All teams should arrive at Ankeny Tennis Courts no later than 7:45am, regardless of the weather conditions. Derek Summy, Des Moines and Sandy Sears, Ankeny, will be the meet managers.**

**All players should be sure to include indoor shoes, with non-marking soles, as part of their gear for state competition due to the possibility of indoor play.**

**The state team series line-up must be the same as the one submitted for sub-state & the quarterfinals of state team tennis, except due to injury, illness, or other excuse verified by a school administrator. *Line-ups & score sheets will be prepared for the meet, distributed at the meet, and can only be changed on the day of the meet with validated permission.***

**If a player is unable to participate in singles competition due injury, illness, or school administrator's validated excuse all team members move up, rather than substituting for the injured or ill player. *Example: If the #3 singles player is absent, #4, #5, #6 move up and #7 now becomes #6.* A substitute must be listed on the line-up form to be used in the tournament.**

**If a player is unable to participate in doubles competition due injury, illness, or school administrator's validated excuse there is no realignment of players. A player is**

simply substituted for the absent player. *Example: If #1 & #3 are playing as part of a doubles team and #3 is unable to compete, player #7 would take the place of #3.* There is no realigning of doubles teams. A substitute must be listed on the line-up form to be used in the tournament.

**Once a substitution has been made, the line-up stays the same for the remainder of the day.**

**The time schedule for Class 2A State Team Tennis is as follows:**

**Tuesday, May 28**

No later than 7:45am	All teams arrive at Ankeny Tennis Courts.
8:00am	Team pictures.
8:15am	Coaches meeting. Play will begin immediately following the coach's meeting. Coaches, please have your players ready at that time.

Championship and consolation finals will take place one hour after the completion of the last match in semifinal play.

Awards will be presented to all four teams at the conclusion of all play.

There are no concessions at this site so teams are encouraged to bring plenty of fluids and food for breaks. Water is available to refill water bottles and coolers.

**All scoring for the championship bracket of sub-state team tennis will be two out of three sets (*any third set in sub-state championship round competition is played as a full set, NOT a 10-point match tie-break*), no-ad scoring, 7-point match tie-break.**

**Consolation play (3<sup>rd</sup> & 4<sup>th</sup>), will be two out of three sets, no-ad scoring, 7-point match tie-break. However, a 10-point match tie-break will be played in lieu of any 3<sup>rd</sup> set.**

**As per the Tennis Coaches Advisory Committee recommendation, the semi-finals and finals of sub-state team tennis competition end when either team scores the fifth team point.**
