Parents and adult fans: The biggest challenge facing high school sports today
An op-ed with NFHS executive director Karissa Niehoff

Inappropriate adult behaviors at high school athletic events across the country have reached epidemic proportion.

When more than 2,000 high school athletic directors were asked in a recent national survey what they like least about their job, 62.3 percent said it was, "dealing with aggressive parents and adult fans."

And the men and women who referee or umpire those contests agree. In fact, almost 60% of new officials registered in lowa in 2016-17 did not return to officiate in 2017-18, and unruly parents are often cited as a major reason why. As a result, there is a growing shortage of high school officials here in lowa, and in baseball, football, track and field, and wrestling, the IHSAA is seeing record lows. No officials means no games.

If you are a parent attending a high school athletic event this fall, you can help by following these six guidelines:

- 1. Act your age. You are, after all, an adult. Act in a way that makes your family and school proud.
- **2. Don't live vicariously through your children.** High school sports are for them, not you. Your family's reputation is not determined by how well your children perform on the field of play.
- 3. Let your children talk to the coach instead of doing it for them. High school athletes learn how to become more confident, independent and capable—but only when their parents don't jump in and solve their problems for them.
- **4. Stay in your own lane.** No coaching or officiating from the sidelines. Your role is to be a responsible, supportive parent, not a coach or official.
- **5. Remember: Participating in a high school sport is not about a college scholarship.** According to the NCAA, only about 2% of all high school athletes are awarded a sports scholarship, and the average total value of that scholarship is only around \$18,000.
- **6. Make sure your children know you love watching them play.** Do not critique your child's performance on the car ride home. Participating in high school sports is about character development, learning and having fun—not winning and losing.

Purchasing a ticket to a high school sporting event does not give you the right to be rude, disrespectful, or verbally abusive. Cheer loud and be proud, but please also be responsible and considerate as a spectator.

The future of high school sports in Iowa is dependent on you.

### Ballard wrestling champ gets awards back after blaze

The IHSAA was pleased to present Ballard's Skyler Noftsger with replacement brackets and medals in August after the 2019 state wrestling champion lost his family home and his hard-earned wrestling awards in a fire this summer.

The July house fire in Cambridge claimed almost everything inside the Noftsger home. A corner of his 2019 bracket board remained inside his bedroom, but his friends and neighbors reached out in the weeks following the incident and were able to help the three-time placewinner get back his belongings.

IHSAA wrestling administrator Lewie Curtis worked with administrative assistant Kim Mechura to recoup the melted medals for Noftsger and track down full results from his state wrestling tournament performances with the Bombers. State tournament calligrapher Zoe Ollendick stepped in complete the traditional championship brackets, then an August meeting was set up at Ballard with wrestling coach Steve Mickelson, athletic director Nate Boock, and Noftsger's parents Drake and Melanie.

"As a mom, it breaks your heart to see your kids lose everything," Melanie told WHO-TV in an August interview after the awards were given back to Noftsger.

"I just knew how much it meant to him, so I wanted to be

there to see that happiness come back."

Noftsger won the Class 2A title at 160 pounds in his senior season and is at South Dakota State this fall as a student-athlete.

### IHSAA associate director Nanninga to step aside

Finalized at August's Board of Control meeting, IHSAA associate director Brett Nanninga will step aside in December following five and a half years of service inside the Boone office.

Nanninga was a two-term Board of Control member and two-time chairperson prior to joining the IHSAA in 2014. He was an administator at Tri-Center, Neola for 26 years, including 10 as high school principal and the last 16 as superintendent. The Nebraska native spent five years as a teacher and coach in his home state before arriving in Iowa in 1988.

Among his varied operational duties at the IHSAA, Nanninga has served as the basketball administrator and oversaw the shift in postseason seeding processes and the 2018 change to a five-day state tournament in Des Moines.

He has also managed the IHSAA's facility and technology operations and served as the office's liason to the Iowa Hall of Pride and the sports advisory and awards committees. Nanninga was an IHSAA representative to the School Administrators of Iowa and the Iowa Association of School Boards during his tenure.

He has been a leading and vocal advocate for interscho-

lastic activities in lowa and is also proud of his work promoting basketball officiating, incorporating new officials into the postseason, and updating technology and usage needs at the IHSAA and at the Hall of Pride in Des Moines.

"It has been my pleasure to serve and represent the member schools of Iowa at the IHSAA," Nanninga said.

### IHSSN announces new 2019-20 TV arrangement

In August, the Iowa High School Sports Network (IHSSN) announced a new distribution plan that will allow boys' state events to be viewed by a much larger statewide audience. IHSSN is the exclusive rights holder for specific broadcast, marketing, and media events of the Iowa High School Athletic Association, including championships in football, wrestling, basketball, track and field, soccer, and baseball. The IHSAA neither owns nor operates IHSSN.

The new network plan will be an over-the-air broadcast on six affiliates throughout the state for the IHSAA's state football finals, state wrestling finals and state basketball finals. Those events also will be streamed live for free on ihssn.com.

The broadcasts will be available on the stations' digital channels. Those channels are accessed by subscribing to a local cable company that provides access to the digital channels or by having a television antenna (attic, wall mount or table top) in your home.



**ONLINE:** All games and all rounds of IHSSN broadcast events available at <a href="ihssn.com">ihssn.com</a>, with the exception of early rounds of the state wrestling tournament. Check <a href="ihssn.com/live">ihssn.com/live</a> for broadcast times and details. Livestream now available to viewers anywhere on internet-connected devices.

**TELEVISION:** The IHSSN will use six over-the-air broadcast affiliates in 2019-20 to carry state football finals, state wrestling finals, and state basketball finals. Those channels are available via antenna or a digital provider (cable or satellite) that provides access to: KDSM 17.1 or 17.3 from Des Moines, KFXA 28.2 from Cedar Rapids, NPTM 42.2 from Omaha, NPTH 44.2 from Sioux City, KXLT 47.2 from Rochester, and WQAD 8.3 from the Quad Cities.



### Inside IHSAA award selections, nominations

The IHSAA is proud to offer numerous awards and honors for administrators, member schools, their supporters and assistants, and Halls of Fame for former student-athletes and coaches. However, these awards are only made possible by the considerations and nominations provided by schools through the Member School Link at <a href="mailto:iahsaa.org">iahsaa.org</a>.

Award categories: Bernie Saggau Award of Merit, School Administrator Award, Friend of School Award, Morris D. Kelley Award for public address announcers, Sports Media Award for media members, and Sports Medicine Award for school sports medicine providers.

Hall of Fame categories: Football for players, Wrestling for players and coaches, Basketball for players and coaches, and Officials.

The process follows four independent steps:

**NOMINATION:** Ideas may from anywhere, but nomination forms for awards must come from member school administrators.

**SELECTION:** Each award process and Hall of Fame has a selection committee who parses through the nomination forms and makes decisions on who to recommend as picks.

**APPROVAL:** The IHSAA's Board of Control, made up of elected and appointed school administrators, has the say on whether to approve or deny committee award and Hall of Fame selections.

**ANNOUNCEMENT:** Different honors are announced throughout the year; sport Halls of Fame are presented during their respective sport championships.

## Baseball

### Perfect weather, pitching shine in 2019 tournament at Principal Park

DES MOINES, Iowa – Great weather and pitching performances carried the 2019 IHSAA State Baseball Tournament at Principal Park, delivering only one extended rain delay in eight days of baseball in downtown Des Moines. The four championships on August 3 were decisively claimed, including two repeat titlists in Class 1A's Newman Catholic, Mason City, and Class 4A's Urbandale.

Nearby Van Meter won its second baseball title by taking the 2A crown, followed by Xavier, Cedar Rapids making a championship-worthy return to the state tournament in 3A. The 2019 audience was bolstered by Iowa High School Sports Network making all games available via free video streaming.

More details from the tournament are below, by class...

### **CLASS 4A**

Even after a nearly three-hour rain delay following the first inning of its tournament opener, Urbandale focused in and allowed just four runs over three games to repeat as 4A champion. Coach Jeremy Heinen's J-Hawks (31-14) entered the tournament as the No. 6 seed, but shutout star-led Epworth, Western Dubuque in the quarterfinals, scored 10 runs on 12 hits in the semifinals over lowa City, West, then held off rival Johnston in a local battle for a state title. Urbandale used five different pitchers over four days and were bolstered by Ty Langenberg's 12-strikeout show in the semifinals. Saturday night's win marked Urbandale's fourth state baseball title.

Top-seeded Johnston returned to the state final for the second time in the last three years, but the explosive offense that featured 4A's home run king Peyton Williams and rolled through CIML foes Ankeny and Dowling Catholic went quiet against the J-Hawks. Four of the five CIML qualifiers were placed on the same side of the 4A bracket, with Urbandale emerging out of the eastern lowa contingent that included Pleasant Valley making its first tournament appearance since 2003.



### **CLASS 3A**

Xavier, Cedar Rapids made its first trip back to Des Moines since 2013 and completed a dominant 41-2 season in the process. The top-seeded Saints allowed just four runs in three games, facing a pitching threat in underdog ADM, Adel, a local rival with Marion in the semifinals, then a red-hot Central DeWitt squad appearing in its first final and coming off the upset of two-time defending champion Assumption, Davenport. Senior Bryson Bastian threw over 100 pitches in the title game to get the Saints across the finish line, striking out 12 and scattering just four hits in the 8-1 win over Central DeWitt.

The Sabers (38-4) were a game runner-up, knocking out defending 2A champ Centerville in the quarterfinals, then holding on against Assumption thanks to pitcher Alex McAleer's 11-strikeout gem. Marion got to the semifinals against Xavier thanks to senior Rick Atkins' lefty performance

against perennial power Bishop Heelan, Sioux City, tossing 16 strikeouts and allowing just three hits in a shutout in the Triple-A ballpark.

### **CLASS 2A**

A competitive class from start to finish, Van Meter was able to take 2A with an offensive explosion in the quarterfinals and shutouts against strong West Sioux and North Linn squads en route to the title. The Bulldogs (34-3) scored 17 runs in their opener over Underwood, then followed it with 17 strikeouts and just two allowed hits from Zach Pleggenkuhle against West Sioux in the semifinals. Van Meter got one final lift in the title game with quarterback Anthony Potthoff throwing all seven innings and holding a confident North Linn squad.

North Linn, the 2A basketball champs last winter, were 1A baseball semifinalists in 2018 and made it back to Principal Park in a record-setting summer for senior Jake Hilmer. The





### Baseball

Lynx (40-6) won one of the tournament's top games against Des Moines Christian in this year's semis, with Hilmer carrying a perfect game into the 7th inning and finishing with 12 strikeouts and just one hit allowed. His opposite number in the game, DMC's Kole Bradley, scattered just three hits in his five complete innings, keeping an anxious crowd on the edge of their seats until North Linn broke through for all three runs in a 3-0 game in the bottom of the 6th.

### **CLASS 1A**

Newman Catholic, Mason City is gobbling up the record books: 12 straight state tournament appearances, 12 straight years as the No. 1 seed, and now three consecutive championships in 1A. Coach Alex Bohl's squad had to hold on in their opener, getting an 8-7 scare from Pekin as the Panthers had the game-tying run on the bases. The Knights rolled from then on: 10-0 vs. Don Bosco, Gilbertville in a five-inning semifinal and 11-1 vs. Alburnett in the six-inning title game.

Senior leadoff Josh Fitzgerald was the standout for Newman, clocking a home run in the championship game and hitting a pair of triples in the semifinals.

Alburnett produced perhaps the highlight of the tournament in the semfinals, escaping a classic contest against St. Mary's, Remsen by laying down a squeeze bunt in the bottom of the 7th to win 4-3. Sophomore Shane Neighbor reached up to knock the bunt as classmate Austin Huber rushed in for the game-winning score. St. Mary's reached that contest supported by sophomore pitcher Blaine Harpenau, who allowed just two hits in his complete game win over Martensdale-St. Marys in the quarterfinals and suffered his first loss of the season in that tense semifinal.

The 2020 state baseball tournament is currently scheduled for July 24-August 1 at Principal Park in Des Moines.



### National participation declines for first time in 30 years

lowa drops to No. 20 in total participation as only 3 states see increase from 2017-18

INDIANAPOLIS, IN — Participation in high school sports declined in 2018-19 for the first time in 30 years, according to the annual High School Athletics Participation Survey conducted by the National Federation of State High School Associations (NFHS).

The 2018-19 total of 7,937,491 participants is a decline of 43,395 from the 2017-18 school year when the number of participants in high school sports reached an all-time record high of 7,980,886. This year's total – the third-highest ever – consisted of 4,534,758 boys and 3,402,733 girls, according to the figures obtained from the 51-member state high school associations, which includes the District of Columbia. The last decline in sports participation numbers occurred during the 1988-89 school year.

"We know from recent surveys that the number of kids involved in youth sports has been declining, and a decline in the number of public school students has been predicted for a number of years, so we knew our 'streak' might end someday," said Dr. Karissa Niehoff, NFHS executive director. "The data from this year's survey serves as a reminder that we have to work even harder in the coming years to involve more students in these vital programs – not only athletics but performing arts programs as well."

The biggest contributors to the decline were the two longstanding and popular sports of football and basketball. Participation in boys 11-player football declined by 30,829 participants to 1,006,013 – the lowest mark since 1,002,734 in the 1999-2000 school year.

Although the actual number of participants in boys 11-player football dropped for the fifth consecutive year, the number of schools offering the sport remained steady. The survey indicated that 14,247 schools offer 11-player football – an increase of 168 from last year. A comparison of the figures from the past two years indicates that the average number of boys involved in 11-player football on a per-school basis dropped from 73 to 70, which would include freshman, junior varsity and varsity teams.

While participation in boys 11-player football dropped in all but seven states, participation in 6-player, 8-player and 9-player gained 156 schools and 1,594 participants nationwide, with the largest increase in boys 8-player football from 19,554 to 20,954. In addition, in the past 10 years, participation by girls in 11-player football has doubled – from 1,249 in the

2009-10 school year to 2,404 last year.

"The survey certainly confirms that schools are not dropping the sport of football, which is great news," Niehoff said. "Certainly, we are concerned about the reduction in the number of boys in-



volved in the 11-player game but are thrilled that states are finding other options by starting 6-player or 8-player football in situations where the numbers have declined.

"While we recognize that the decline in football participation is due, in part, to concerns about the risk of injury, we continue to work with our member state associations, the nation's high schools and other groups to make the sport as safe as possible. Every state has enacted rules that limit the amount of contact before the season and during practices, and every state has concussion protocols and laws in place, so we continue to believe that the sport is as safe as it has ever been.

"We also are working with groups such as USA Football to reduce contact and teach proper tackling skills at the youth levels to increase the interest level as kids reach junior high school and high school."

The top 10 states by participants remained the same in 2018-19. Texas and California topped the list again with 825,924 and 824,709 participants, respectively, followed by New York (369,266), Ohio (339,158), Illinois (333,838), Pennsylvania (316,429), Florida (308,173), Michigan (292,947), New Jersey (281,058) and Minnesota (240,487). Only Texas, California and Minnesota reported higher figures than the previous year.

The participation survey has been compiled in its current form by the NFHS since 1971 through numbers it receives from its member state associations.

IHSAA BASKETBALL COACHES ADVISORY COMMITTEE - Associate Director Nanninga presented the minutes of the Basketball Coaches Advisory Committee. The committee made five recommendations. 1) To have the IHSAA provide a HUDL video pool for state tournament teams. 2) To increase the number on the state tournament roster from 15 to 18. 3) To adjust the postseason calendar to start the 1A tournament on the previous Friday or Saturday. 4) To draft a letter to the Department of Education to expand the coach-athlete contact rule. 5) To move the state tournament to Hilton Coliseum in 2021.
