Good afternoon, Head Tennis Coaches & AD's –

Hope everyone is getting excited and prepared for the upcoming tennis season. Below are a few reminders as we are just a little over a week out from the official start of the 2025 season:

### **1. Online Rules Meetings**

The 2025 tennis rules meeting is live through Bound and required to be completed by all head coaches for postseason eligibility. If you are new to your program or district, please have your AD create and assign an account for you. **Coaches have until Friday, April 4 to view and receive credit.**

### **2. Tennis Host Sites**

AD's & Head Coaches, please ensure you have completed the host availability form within Bound if you are able & willing to be a host site for postseason tennis. If you have adequate tennis facilities, we encourage you to be a host.

### **3. Tennis Coaches Workshop**

For coaches interested, there will be a tennis workshop opportunity offered. Like past years, this clinic has been approved to count towards 1 renewal credit for your coaching licensure. ### **4. Postseason Format**

Reminder with the individual and team tournaments running independently, if you wish to opt out of the team portion (per manual, must have 6 eligible players for team), your school's AD must submit this request on school letterhead. Submitted prior to substate assignments being released the week of April 28.

### **5. 2025 IHSAA Dates**

If you haven't yet looked ahead, please check out the dates assigned to boys' tennis for the 2025 postseason. These are available through the digital [Calendar - High School Boys' Sports | IHSAA \(iahsaa.org\)](#), in the calendars on our [Coaches & Administrators page](#), and are also listed in the [2025 IHSAA Tennis Postseason Manual](#) that is also now available.

### **6. Preliminary Classifications**

Check [IHSAA Preliminary Classifications](#) posted. If you are involved in a co-op, ensure that it is listed. If you feel you may need to create one, this needs to be completed prior to the official start of the regular season (March 17, 2025).

### **7. Universal Tennis**

Reminder that UTR is required for 1A to enter rosters and 2A to enter rosters and all results throughout the season. Bound is working to have information sync to eliminate double entry and will update everyone as we progress with this.
