Good morning, Head Tennis Coaches, ADs, & Asst. AD's -

Below is some information regarding data entry into Bound/UTR now that we all have had some opportunities to get matches in, along with some questions arising. I have also included some postseason information/reminders. I know this is plenty early but want to ensure this information is to all of you in a timely manner.

1. Bound – UTR Data Entry

Everything seems to be populating and meet results entered into Bound will be synced into UTR. I wanted to assess the first two weeks of competitions before sending this out. Data will be exported twice a week from Bound to UTR. Please ensure rosters entered into Bound and UTR match so data can be synced appropriately. Rosters do need to be manually entered into both platforms (should be done already). I Would encourage all coaches check data exported periodically throughout the season to ensure accuracy. With this being year one of data exporting, we want to ensure we work proactively in year one to track how it works.

2. <u>District Singles & Doubles</u>

District singles and doubles host sites are now posted <u>HERE</u>. A big thank you to all the schools that have taken on these hosting responsibilities for all our tennis programs.

- District assignments will be released the week of April 28.
- District singles & doubles will be played on Wednesday, May 14 (rain date is May 15).
- 1st and 2nd place at each district site will advance to the 2025 state singles & doubles tournament.

3. Substate Team

Substate Team tennis assignments will be released at the end of the week of April 28.

- Once assignments are released, coaches seeding meetings will be set up for each substate, then brackets and host sites will be set. Seeding meetings should take place during the weekend of May 2-4.
- Substate team tennis dates:
 - o The first and second rounds of substate will be played on Saturday, May 17 (rain date is May 19).
 - The substate final will be played on Wednesday, May 21 (rain date is May 22).
- First place team from each substate bracket will advance to the 2025 state team tournament.

4. Postseason Manual
